Executive orders, directives, memos, and policy shifts have been issued recently







Timeline of Events

OMB Memo: Federal Funding Pause

January 27 OMB issued a memo requiring a temporary pause in all activity and a mandatory review of all funded agencies and programs

January 29, OMB rescinded the federal funding pause.









January 28 lawsuits were quickly filed, resulting in an administrative stay for one week

February 3, a temporary injunction halting the funding pause was approved (extended on February 10 and 25) and is currently in effect.





Timeline of Events

National Institutions of Health (NIH) Notice

February 7 NIH issues a Notice, imposing a standard IDC rate of 15% stated effective February 10, an indirect cost rate cap of 15% would be in place for new and any expenses incurred on or after that date for existing grants.

February 10, the court issued a temporary restraining order, directing NIH from implementing the policy while the case proceeds, (extended on February 21) and is still in effect.







A lawsuit was brought in federal court seeking to prevent the implementation of this change to the policy.





Timeline of Events

Executive Order: Anti-Discrimination

January 21 EO "Ending Illegal Discrimination and Restoring Merit-Based Opportunity" was issued which could affect federal grant recipients with DEI (Diversity, Equity, and Inclusion) programs.

Some agencies have also issued directives to awardees to cease working on elements of their funded projects related to DEI and accessibility.









Requires all federal grantees certify they do not run programs that promote DEI in a way that violates "antidiscrimination" laws.

Lawsuit has been filed.
